TERMS OF SERVICE

- A) **TRAVEL FEE:** THE ARTIST PROVIDES MAKEUP SERVICES FOR CLIENTS, WITHIN ONE HOUR (DRIVING DISTANCE) FROM WARWICK, NY. IF THE CLIENT REQUIRES FURTHER TRAVEL, AN ADDITIONAL \$50 TRAVEL FEE WILL BE REQUIRED.
- B) **RESERVING YOUR DATE:** A 50% DEPOSIT WILL BE REQUIRED TO BOOK SERVICES FOR YOUR WEDDING DATE. THIS DEPOSIT WILL BE CREDITED TOWARD YOUR BALANCE OF THE WEDDING DAY TOTAL, AND IS REQUIRED TO HOLD YOUR

DATE. THE REMAINING BALANCE MUST BE PAID ON THE WEDDING DAY, PRIOR TO ANY SERVICES BEING PERFORMED. ONCE THIS CONTRACT IS COMPLETED & DEPOSIT IS RECEIVED, YOUR DATE IS OFFICIALLY BOOKED.

- C) **ASSISTANT ARTIST FEE:** FOR BRIDAL PARTIES WITH A SMALL WINDOW OF TIME TO GET READY, THE ARTIST ALONE MAY NOT BE ABLE TO COMPLETE THE TOTAL NUMBER OF SERVICES WITHIN THAT TIME. BE ADVISED THAT EACH SERVICE WILL TAKE ABOUT 35-45 MINUTES. IN THIS CIRCUMSTANCE, TO ENSURE THAT EVERYONE IS READY ON TIME, AN ASSISTANT ARTIST MAY BE NECESSARY TO HELP PERFORM SERVICES. THE ASSISTANT ARTIST FEE IS \$75 AND WILL BE ADDED TO THE WEDDING DAY PRICE TOTAL. THIS WILL BE DISCUSSED BETWEEN THE ARTIST & THE CLIENT BEFORE THE EVENT DATE.
- D) **CANCELLATIONS:** IN THE EVENT THE CLIENT DECIDES TO CANCEL SERVICES, THE CLIENT WILL LOSE THE DEPOSIT(S) MADE TO THE ARTIST. ONLY, IF THE CANCELLATION IS MADE WITHIN 14 DAYS FROM SIGNING THIS CONTRACT SHALL THE CLIENT RECEIVE A 100% REFUND OF THE DEPOSIT.
